## AGREEMENT ASSUMING ALL RISKS AND RELEASING LIABILITY

I hereby acknowledge:

- 1) That I have been authorized to take a demonstration ride on a cycles de ORO, Inc. bicycle
- 2) That I am competent to perform a safety check and will personally perform a safety check of the demonstration bicycle prior to my ride.
- 3) That I am competent to safely ride the demonstration bicycle, and will observe safe riding practices and obey all laws.
- 4) That I will wear all appropriate safety equipment at all times, including a bicycle helmet. \_\_\_\_\_(initial)
- 5) That bicycling is inherently dangerous, presenting a great number of risks, such as the risk of falling, encountering hidden obstacles or varying terrain, or the risk of injury from any failure of the bicycle or any of its components.
- 6) That I freely and expressly accept all risks associated with bicycling on my demonstration ride, including all risks of injury or death. \_\_\_\_\_(initial)
- 7) That I agree to return the bicycle in the same condition it was loaned.
- 8) That I agree to assume all costs due to loss, theft or damage of the bicycle \_\_\_\_\_(initial)
- 9) I agree to a **\$50.00 cleaning charge** to my credit card if the bicycle is returned in a dirty condition. \_\_\_\_\_(initial)
- 10) \* I agree that I will return this bicycle within 24 hours and I authorize the charging to my credit card of \$100 per additional day (or any portion there of.) \_\_\_\_\_(initial)

**ON MY OWN BEHALF, AND ON THE BEHALF OF MY HEIRS, ASSIGNS, AND PERSONAL REPRESENTATIVES, I HEREBY FULLY AND FOREVER DISCHARGE AND RELEASE CYCLES DE ORO, INC., AND THEIR VENDORS, SUPPLIERS, EMPLOYEES, AGENTS, SPONSORS, INSURERS AND ALL OTHER PERSONS OR ENTITIES FROM ANY AND ALL LIABILITY, CLAIM, LOSS, COST OR EXPENSE ARISING DIRECTLY AND INDIRECTLY FROM MY DEMONSTRATION RIDE AND-OR USE OF THE DEMONSTRATION BICYCLE.**

I expressly agree that the foregoing agreement shall be construed to provide the parties being released with the broadest relief possible. If any portion is held invalid, the balance shall continue in full legal force and effect. The agreement shall be governed by the laws of the State of North Carolina and any litigation between parties shall be filed in the Municipal or Superior Court of the County of Guilford, State of North Carolina.
